
A Student Model

Some people say that these companies should hire more women. Others say that it is not necessary for there to be more women in that industry. What is your point of view? deas. The discussions about products will be different because these women will challenge the men's ideas. Secondly, women could help to design products for women. Since women make 85 percent of consumer purchases ("Marketing to Women"), their preferences are important. Women engineers could help companies design products that really address their needs. For example, one app was easily activated by tapping a phone in a pocket. However, a female engineer pointed out that women often keep phones in purses. As a result, the design of the phone was changed. It is clear that women in technology would give a new perspective on ideas.

If there were more women as leaders, technology companies would be more successful. According to a study by the *Harvard Business Review* (Zenger and Folkman), women were given higher ratings in their leadership abilities. They were better at leading employees and achieving results. Some examples of successful women leaders who have shown strong leadership are Sheryl Sandberg of Facebook and Marissa Mayer of Yahoo. Also, since there are not many women in technology, women do not feel comfortable and they work harder. Men feel comfortable in technology, so they may not work as hard as women. It is possible that women leaders could make companies achieve more.

- Most importantly, our society will benefit from more women in technology companies. First, these jobs will help women take care of their families. There are many single mothers who are raising children in this country. Since technology jobs pay well, the single mother will be able to live well and not worry about her finances. In addition, these jobs will also benefit mothers who must work to help their husbands make enough money to raise a family. Second, if women get these jobs, they can be role models for younger girls and encourage them to study for jobs in technology. It is clear that hiring women for tech jobs will make families stronger and society more stable.
- In sum, hiring more women in tech jobs would benefit companies by making them more creative and successful, and this change would benefit society. This will happen only if companies change their ideas about hiring women, and this may not be easy for them to do. Also, teachers must encourage girls to consider careers in tech jobs. In my case, I plan to work in a tech job and will be proud to be a role model for young girls.

B Argumentative Essays

The ability to write argumentative essays is essential in academic writing. You will often be asked to give your point of view on a topic that you have discussed in class. Stating your point of view clearly and supporting it using information from texts and your experience is a key skill in both speaking and writing. This skill will help you be successful both in school and in your career.

WHAT IS AN ARGUMENT?

An argument is an opinion, or a point of view, with reasons and evidence to prove that the point of view is valid. An argument tells the reader, "I believe that my point of view is a good one, and I have persuasive reasons supported by facts and research to prove it." A successful argument makes your reader understand and recognize that your point of view has some value; however, it does not mean that your reader will in the end change their opinion and agree with you.

The Student Model writer's argument is summarized below.

Student Model Writer's Argument: Companies should hire more women in technology because they would be more innovative, they would be more competitive, and society would be much stronger.

Reasons and Evidence for Argument: Increasing the number of women in tech positions would make companies more innovative since the diversity of women from different cultures would make the workplace more creative. Women would challenge ideas and bring new ones. It would make the companies more competitive since women have a lot of power as consumers and they are good leaders. Finally, it will benefit society because more women will be able to take care of their families, especially single mothers, and these women will be role models to young girls and encourage them to choose careers in technology.

DEBATABLE TOPICS

When writers choose a topic for an argumentative essay, they must make sure that they choose a debatable topic. Debatable topics are those that people have serious disagreements about, such as women's rights, freedom of religion, animal rights, free higher education, and the death penalty.

On the issue of "Should higher education be free?," three points of view are:

Point of view 1: Higher education should be free because if a country's citizens are all educated, there will be more skilled workers. More skilled workers means that companies will produce more and sell more.

Point of view 2: Higher education should be free because it is a citizen's basic right. It should not matter if a person is rich or poor. Everyone should get a good education.

Point of view 3: Higher education should not be free because if it is free people will not work hard or care about their studies. People will not be educated or competitive. As a result, the economy will suffer.

Other debatable topics include "Should governments control the Internet?," "Is marriage necessary?," "Should men and women receive equal pay for the same job?," and "Is a job a human right?"

THE STRUCTURE OF AN ARGUMENTATIVE ESSAY

Writers carefully construct each part of their essay because each part has a specific purpose.

- 1 The **introductory paragraph** gets the reader's attention, convinces the reader that the topic or issue is important, and leads the reader to the thesis statement. It consists of:
 - a **hook**, such as a famous quote, a story, a surprising or alarming fact, or a statistic about the issue
 - background information, which explains the issue, its importance, the different sides of the debate, and information that introduces the thesis
 - the **thesis statement**, which usually contains the points that the writer will prove in the body paragraphs
- 2 The **body paragraphs** build the argument by explaining each reason and giving clear evidence such as facts, examples, personal experiences, and research to convince the reader that the reason is valid.
- 3 The **concluding paragraph** summarizes the argument and reminds the reader why the topic is important. It ends with a memorable closing statement, quotation, or call to action.

WRITING AN INTRODUCTORY PARAGRAPH

The introductory paragraph in an argumentative essay has a lot to accomplish. As mentioned earlier, it:

- gets the reader's attention and interest using a hook
- explains a little bit about the issue and the different sides of the debate so that the reader understands what the issue is, what people are saying about the issue, and why the thesis statement makes sense
- ends in the thesis statement

If the introductory paragraph is uninteresting or vague, the reader will have difficulty reading and understanding the rest of the essay.

STRONG AND WEAK THESIS STATEMENTS

In an argumentative essay, the **thesis statement**, also called a **claim**, states the writer's point of view. A strong thesis statement:

- Answers the prompt with a clear point of view. The prompt may ask you to agree or disagree, to say whether something is or is not a problem, or to say whether something is or is not true. It contains the word *should* if necessary.
- Uses key words from the prompt that are part of the question and the issue.
- Gives specific reasons that are clear and could be supported by evidence.

Read the writing prompt and the weak and strong thesis statements that follow. Notice the differences between the two.

WRITING PROMPT: Tech companies are not known for the diversity of their workforce. In fact, in some of the largest tech companies, almost three-quarters of their workforce is made up of young males, mostly Caucasian. There has been a lot of debates about whether these companies should be more diverse and include more diversity in gender and ethnicity. What is your point of view? Should tech companies hire people with more diverse backgrounds?

Strong Thesis Statement: Tech companies should hire more people of diverse backgrounds because companies with a diverse workforce are more innovative, the workforce should reflect the people in the society, and someone's gender or ethnicity should not determine who gets a job.

This thesis statement is strong because:

- 1 The point of view is clear. The writing prompt has *should* in it, and the thesis statement does, too. The writer thinks that the lack of diversity is a problem and that tech companies should hire more women and people of different ethnicities.
- 2 The writer includes key words such as tech companies, gender, and hire.
- 3 The reasons are clear, support the point of view, and could be supported by evidence.

Weak Thesis Statement: There are not many women or different kinds of people in technology jobs, but this is how our society is.

This thesis statement is weak because:

- 1 The point of view is not clear. The writing prompt has *should* in it, but the thesis statement does not, so it does not answer the prompt.
- 2 The thesis does not contain key words from the question or about the topic.
- 3 The reasons are not clearly stated, and it is not apparent what the reasons will be.

MORE ABOUT THESIS STATEMENTS

Thesis statements do not have to list the reasons or points. Read the thesis statements below. One thesis statement does not give the specific reasons for the reader, but they both clearly indicate what the writer will discuss in the body paragraphs that will follow.

Thesis Statement 1: Living in a multicultural society is challenging because you have to adjust to different social norms, deal with feelings of isolation, and change your habits. (The writer includes three specific reasons for the point of view.)

Thesis Statement 2: Living in a multicultural society is challenging because people must always make adjustments and these adjustments can be difficult. (The reasons are not specific, but the reader knows that the writer will discuss adjustments and why they are sometimes difficult.)

BUILDING AN ARGUMENT IN THE BODY PARAGRAPHS

Each **body paragraph** in an argumentative essay has a clear goal. The goal is to make the reader, especially the reader who disagrees with you, say, "I may not totally agree with your argument, but this paragraph sure is convincing!"

Each body paragraph consists of:

- a **topic sentence** that links to the thesis statement by repeating important words from the thesis statement in it
- evidence, such as facts or statistics, quotations or examples, logical reasons, or personal
 experiences, and an explanation that shows how the paragraph supports the topic
 sentence

Below are examples of the types of evidence that writers use.

1 Facts: Facts are ideas that can be proven or are accepted as true. They make your arguments seem valid.

Today, Russia and the United States are two of the top destinations for immigrants.

2 Statistics: Figures are numbers, data, or statistics that come from research, surveys, or polls. They make your arguments more credible.

Over 800,000 immigrants arrived in the United States in 2013.

- 3 Quotations: Quotations are relevant phrases and sentences that are copied from another source, put in quotation marks, and properly credited. In a study by Harvard Business Review, researchers found that women were rated as "better overall leaders than their male counterparts" (Zenger and Folkman). Zenger, Jack and Joseph Folkman. - 4 Examples: Examples are specific stories or cases that illustrate a point. They help the reader imagine and understand what you mean. Imagine a Saudi man, a U.S. woman, a Dominican man, and an Egyptian woman all discussing ways that the company can improve its sales in the global market. Each person will have a unique perspective on the various markets. This conversation will be much more valuable than one between four people of the same gender and culture.
- 5 Personal Experiences: Personal experiences are stories that happened to you or someone you know. They make your arguments more real and believable. In 2007, my family immigrated to Manitoba, Canada. That same year, my parents opened a Filipino restaurant in a small town in Manitoba. After working hard for many years, my father has become a respected leader of the community.

Whichever you choose, strong evidence is key. To find strong evidence, ask yourself these questions:

- What facts or statistics would most likely convince my reader?
- What quotations or examples clearly support my opinion?
- What personal experiences would make my opinion more believable and persuasive?

CONCLUDING PARAGRAPH

The concluding paragraph tells the readers what you want them to remember about your essay. It is your last chance to restate your argument, say why the topic is important, and convince the readers to agree with your point of view. Writers often create a memorable ending by leaving the readers something to think about: a strong closing statement, quotation, or call to action.




